The High Divide Community-Based Conservation Capacity Building Initiative is centered on building the capacity of community-based conservation organizations in the High Divide Region - the chain of Montana and Idaho counties that link the Greater Yellowstone Ecosystem to the wildlands of central Idaho. This initiative is focused on training programs that help these organizations be more successful and sustainable in their conservation and community development efforts. In addition to grant-writing, strategic planning and facilitation services, we also offer workshops tailored to organizational development and 'back office' training. In 2016, we hosted two well-attended regional gatherings that in addition to skill training also provided leaders of these organizations the opportunity to network, share best practices, and provide a venue for collective action.

The High Divide Conservation Project consists of several site-specific conservation activities in the region between southwest Montana and eastern Idaho. Specific accomplishments this year include administering the Big Hole River Payment for Ecosystem Service Program, advancing landscape conservation in the Henrys Fork Watershed in Idaho, elevating public understanding of growth issues and their impacts, and reshaping development patterns in the Madison Valley to ensure intact wildlife corridors in partnership with the Montana Land Reliance.

The Mountain Time Arts program is a public art initiative. The program's mission is to produce bold and engaging public art projects that explore the history, culture and environment of the Rocky Mountain West. FLOW is the program's premiere project. The program is currently developing a series of temporal site-specific, public artworks that focus on water conservation. This multi-year project entitled WaterWorks is currently being developed in partnership and collaboration with numerous local organizations and individuals throughout the Gallatin Watershed. WaterWorks projects will be presented in the Gallatin Valley in 2017-18.
