Mountain Time Arts produces inventive public art projects that enliven our relationships to the history, culture, and environment of the Rocky Mountain West. MTA nurtures authentic relationships around creative ideas that respond to issues of our times. MTA produced five art projects in the Gallatin Valley in 2017 which allowed participants to share perspectives and build a culture of engagement leading to a resilient community.

The High Divide Community-Based Conservation Capacity Building Initiative is centered on building the capacity of community-based conservation organizations in the High Divide Region - the chain of Montana and Idaho counties that link the Greater Yellowstone Ecosystem to the wildlands of central Idaho. This initiative is focused on training programs that help these organizations be more successful and sustainable in their conservation and community development efforts. In addition to grant-writing, strategic planning and facilitation services, we also offer workshops tailored to organizational development and 'back office' training. In 2017, we hosted a well-attended regional gathering that in addition to skill training also provided leaders of these organizations the opportunity to network, share best practices, and provide a venue for collective action.

The High Divide Conservation Project consists of several site-specific conservation activities in the region between southwest Montana and eastern Idaho. Specific accomplishments this year include advancing landscape conservation in the Henrys Fork Watershed in Idaho, elevating public understanding of growth issues and their impacts, and reshaping development patterns in the Madison Valley to ensure intact wildlife corridors in partnership with the Montana Land Reliance.
