The High Divide Community-Based Conservation Capacity Building Initiative is centered on building the capacity of community-based conservation organizations in the High Divide Region the chain of Montana and Idaho counties that link the Greater Yellowstone Ecosystem to the wildlands of central Idaho. This initiative is focused on training programs that help these organizations be more successful and sustainable in their conservation and community development efforts. In addition to grant-writing, strategic planning and facilitation services, we also offer workshops tailored to organizational development and back office training. In 2018, we hosted two workshops that in addition to skill training also provided leaders of these organizations the opportunity to network, share best practices, and provide a venue for collective action.

The High Divide Conservation Project consists of several site-specific conservation activities in the region between southwest Montana and eastern Idaho. Specific accomplishments this year include advancing landscape conservation in the Henrys Fork Watershed in Idaho, elevating public understanding of growth issues and their impacts, and reshaping development patterns in the Madison Valley to ensure intact wildlife corridors in partnership with the Montana Land Reliance. In addition, Future West launched its Successful Communities initiative which helps communities craft a shared vision for the future and an action plan for achieving it.

Montanans for Safe Wildlife Passage is a coalition of non-governmental organizations working to encourage the Montana Department of Transportation to initiate "safe wildlife passage" projects on Montana highways that reduce wildlife-vehicle collisions. A major accomplishment in 2018 was the convening of the State's first Wildlife-Transportation Summit which brought together representatives from MDOT, the Department of Fish, Wildlife and Parks and representatives of the NGO community to discuss these issues.
