Montanans for Safe Wildlife Passage is a coalition of non-governmental organizations working to encourage the Montana Department of Transportation to initiate safe wildlife passage projects on Montana highways that reduce wildlife-vehicle collisions. A major accomplishment in 2018 was the convening of the State's first Wildlife-Transportation Summit which brought together representatives from MDOT, the Department of Fish, Wildlife and Parks and representatives of the NGO community to discuss these issues. In 2019, Future West has assisted in implementing the actions recommended at the statewide Summit. Specifically, Future West staff sit on a steering committee made up of representatives from related state agencies and well as members of the non-governmental conservation community.

The "Successful Gardiner Project" is an effort to help the community of Gardiner, the first gateway community to Yellowstone National Park, identify the major challenges facing the well-being of the town as well as the priority actions needed to resolve these problems. A "Gardiner Community Profile" was completed which documented socioeconomic and land use trends in the community. This was used to identify top community development issues such as the lack of affordable housing. Two community forums were facilitated to present and discuss these issues and begin to chart a course for dealing with them. The community is now deciding which of those actions to pursue.
